

CONFIDENTIALITY AGREEMENT

We hereby inform our Users about our Confidentiality Agreement. It is applicable from the use or access to wellwordstudio.com (Wellword or the Website); thus, it is understood that you accept it and agree to comply to it.

CONFIDENTIAL INFORMATION

Information will be deemed anything that the User shares with Wellword, be it in print, in written form, contained in electronic media or in computer programs (software). The term Confidential Information also includes any derivatives of it, that is to say, any improvement, overview, adaptation, or any other modifications to this Confidential Information.

The term "Confidential Information" shall not include any information which Wellword can demonstrate that:

(a) it has been independently developed by Wellword or has been legally received without restriction from another source, which has the right to provide such information, or

(b) has become available to the general public, or

(c) prior to the date in which it was delivered to Wellword, such information was properly in possession of Wellword, free of any restrictions, which must be shown by documentation in the possession of Wellword

OBLIGATION OF CONFIDENTIALITY

Confidential Information shall be kept confidential by Wellword, and Wellword may not, without prior consent in writing from the User: (i) distribute or disclose any portion of this Confidential Information, by any means; (ii) permit any third party access to this Confidential Information, or (iii) use said Confidential Information for any purpose other than that requested by the User. Nonetheless, Wellword can transmit Confidential Information to its employees, who will be informed of the content of these policies and will give their consent to be bound under its terms.

Wellword shall maintain the User's Confidential Information as confidential, to prevent any access to it, its reproduction or disclosure. In the event that Wellword should become aware of unauthorized access or disclosure of this Confidential Information, it will notify the User.

DISCLOSURE OF INFORMATION BY JUDICIAL OR ADMINISTRATIVE ORDER

Should Wellword receive an order to disclose all or part of the User's Confidential Information from a competent court or any government entity or administrative authority, Wellword will only reveal part of this Confidential Information, that which is requested.

INTELLECTUAL PROPERTY

Both Wellword and the User agree not to violate intellectual and/or industrial property rights that might be contained in the information provided, under warning of incurring in sanctions, penalties, crime, or the payment of damages that could be generated by the disclosure of your information.

USE IN ACCORDANCE TO PURPOSE

Wellword agrees to utilize the User's confidential information solely for the purpose of providing the service that the User requests.

RESPONSIBILITY

Wellword recognizes, for all legal purposes, that revealing, disclosing, using, or taking advantage for its benefit or for that of third parties, of any confidential information and reserved property of the User, constitutes a wrongful act, and manifests awareness of crimes and responsibilities that could result from a breach.

RETURN OF CONFIDENTIAL INFORMATION

At a User's request, all documents, records, materials or similar, including each and every one of the copies that have been made thereof, containing Confidential Information that are in the possession of Wellword, will be delivered to the User.
